What should you know about labour & social rights?

- The employment contract shall in minimum include the description of your duties, workplace, working hours and salary amount. The contract often refers to the collective agreement concluded between the employers' association and the trade union:
- There is no legally unified minimum wage in Belgium, however minimum wages are offered in all sectors via the collective labour agreements (e.g. the minimum gross salary for a person of 21 and older, without working experience is EUR 1.472.40 a month);
- The legally established working week is 38 hours;
- Every worker is entitled to annual leave.
 Its minimum duration per year is 20 days (in case of 5-day working week) or 24 days (in case of 6-day working week);
- The social security system of Belgium consists of unemployment, health, family allowances, pension and work accident insurance and is financed through a combination of employer and employee contributions. The registration to the Social Security System has to be done by your employer. Some of these rights are tightly linked with the right to reside in Belgium (more information available on: www.coming2belgium.be);
- To be entitled to receive any unemployment benefit you need to prove certain period of work in Belgium prior such application (depends on the age category, but the minimum is 312 days in last 18 months);
 Health insurance is obligatory. You can choose which of the public health insurance funds you want to be registered with.

Are you interested in working in Belgium?

This leaflet provides you with general guidance on how to obtain a work and residence permit and gives you brief overview of work related rights and useful contacts to search for additional information or assistance if needed.

STEPS to be followed:?

- Check the list of occupations/professionsyou are allowed to work in.
- 2. Secure a job offer from an employer in Belgium.
- 3. Apply for a long term visa (after labour authorization and work permit is issued).
- 4. Get registered at the municipal authority of your residence and apply for a residence permit.

There is no agreement on bilateral labor migration between Georgia and Belgium therefore Georgian citizens are not eligible to work in all types of occupations/professions. Still there are a number of professions/ occupations where neither this precondition nor the rule of priority given to the Belgian or other EU citizens applies. In the below listed professions the citizens of Georgia can apply for a job:

- highly qualified employees or executives
- researchers and visiting professors
- trainees (aged 18-30)
- au pairs (aged under 26)
- professional sportsmen and their coaches
- performing artists
- spouses and children of labour migrants with a temporar work permit
- employees with a key position in a foreign air company or tourist industry

Schemes for highly qualified employees:

1.National scheme (work permit B):

- requirements: possession of a degree of higher education (successful completion of higher education of at least 3 years) and minimum annual gross salary of EUR 37.721
- the permit is annually renewable (max.8 years: 2times for 4 years). If the salary exceeds EUR 62.934 annually, no time limitations are set.

2. Blue Card (scheme introduced by the EU):

- requirements: diploma of higher education (successful completion of higher education of at least 3 years) and minimum annual income of EUR 49.995 gross.
- work contract must be min. 1 year.
- the decision on Blue Card is taken within 90 days once the application and all submitted documents were accepted.
- Blue Card is issued for 13 months, renewable for. another 13 months and after that for 3 years.

Procedure on work permit and residence permit:

There are separated procedures on work and residence permits. Your employer initiates the procedure on work permit and you are responsible for a long term visa (and residence permit) application. First, your employer has to ask for the labour authorisation and work permit for you at the competent regional authority in Belgium. Once the work permit is arranged, you can apply for a long term visa. After the long-term visa is issued, you can come to Belgium and start working. You must get registered at the municipal authority of your residence within 8 days upon arrival and apply for the **residence permit**.

Where to apply forvisa?

There is no Belgian diplomatic mission in Georgia.

For **a long term visa**(over 3 months) Georgian citizens can apply at <u>Visa Application Centre</u>

Visa applications are handled by the company IKS (http://www.iks.com/). It is not necessary to come in person to Ankara as visa applications/visa can be submitted/deliveredby post.

What documents are required for visa?

- National passport valid for at least 12 months, in which a visa can be affixed.
- 2 visa application forms duly completed, signed and attached with 2 recent passport photos.
- Original valid type B work permit.
- An extract from your criminal record issued no later than 6 months prior the application date and covering the past year.
- A medical certificate filled out by a doctor affiliated with the Belgian embassy (you can ask for the contact details by phone in the Visa Application Centre in Ankara) and issued no later than 6 months prior the application date (medical certificate is not required if it was enclosed already to the work permit application);

Documents issued abroad in a language other than Dutch, English, French or German must be translated by an authorized interpreter.

What are the application fees?

The total costs to obtain a long-term visa isapprox. EUR 275: EUR 180 (for visa) + EUR 20 (IKS service fee) + approx. EUR 75 for delivering the visa from Turkey to Georgia. The residence permit fee varies between EUR 20-30.

What is the validity of visa, work and residence permits?

The validity of a long term visa is usually 6 months. The residence permit is issued with the validity of 30 days beyond the validity of the work permit. The validity of the work permit is usually1 year. There are 2 extensions possible for maximum 4 years each (8 years in total).
